



DOWNTOWN JONESBORO JOY FEST VENDOR APPLICATION 2025

Thank you for requesting an application to participate in the 7th annual Downtown Joy Fest. Joy Fest will take place on Saturday, December 6, 2025 in Downtown Jonesboro at Union Park. For questions about this application or the festival, please contact Sarah Rickert at (870) 897-9456 or events@downtownjonesboro.com. Below are a few key items for renting booth space at Joy Fest. Please read all terms and conditions before submitting the application.

- Cost is \$100 for Joy Fest booths. Vendors are responsible for bringing a 10x10 tent, if they choose to have a tent. Electricity will be provided but you must bring your own extension cords. **ALL BOOTHS MUST HAVE PRODUCT FOR SALE.** **White tents are required at Joy Fest for a spot in the Barton's Vendor Village. All other color tents will be permitted but in a separate area.
- Once you receive an email confirmation from Sarah Rickert at events@downtownjonesboro.com payment for booth space must be sent via Cash App, Venmo or in the form of a check or money order payable to Downtown Jonesboro Alliance. If a Vendor is not selected to participate, the Vendor will receive an email notification. If accepted, **no refunds will be given.**
- All vendors are responsible for paying their own sales tax. All Vendors must furnish their own tent (white tent if your tent will be located in the Barton's Vendor Village), tables, chairs, extension cords, etc. Weights to secure tent are highly recommended and tent sides are welcome. Lights and Christmas decorations are also necessary at Joy Fest, as it is a nighttime event.
- Applications that are not signed and dated or that fail to include pictures of products that vendor will be selling, will be denied automatically. A signed application is a contract to participate, if accepted.
- If accepted, an email with information on booth location, check-in time and other festival details will be provided to Vendor, as well as how to submit payment for vendor fee. ****Please do not pay through any links or to any individuals on social media, as these are scams.**
- All booths must remain open as follows:

Joy Fest: Saturday, December 6, 2025 from 3:00 pm to 8:00 pm and are welcome to stay open until the Ferris Wheel closes.

****All vendors need to be set up and ready 30 minutes prior to event start time.**
